as a ground ALS and BLS ambulance service in the State of Arizona for the transportation of individuals who are sick, injured, wounded or otherwise incapacitated or helpless within the following service area, with the following central operations station and response times:

### 1. Service Area:

*Beginning at the northeast corner of Section 20, T16N R13E,  
then South to southeast corner of Section 17, T15N R13E,  
then West to southeast corner of Section 14, T15N R12E,  
then South to southeast corner of Section 35, T15N R12E,  
then West to southeast corner of Section 33, T15N R12E,  
then South to the southeast corner of Section 09, T14N R12E,  
then West to the southeast corner of Section 07, T14N R12E,  
then South to southeast corner of Section 18, T14N R12E,  
then West to the southwest corner of Section 14, T14N R11E,  
then North and West to State Route 87 Milepost 300.1,  
then South and West to the southwest corner of Section 26, T14N R9E,  
then North to the northwest corner of Section 35, T15N R9E,  
then East to northwest corner of Section 34, T15N R11E,  
then North to northwest corner of Section 27, T15N R11E,  
then East to northeast corner of Section 25, T15N R11E,*

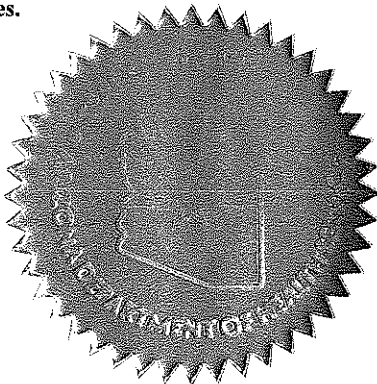
Now, therefore, by virtue of the authority vested in the Arizona department of Health Services, under the constitution and laws of the State of Arizona, does hereby grant this


## CERTIFICATE OF NECESSITY
