THE ARIZONA DEPARTMENT OF HEALTH SERVICES has found, under the authority of A.R.S. § 36-2232 et seq and Pursuant to Department of Health Services rules, that public necessity requires the operation of

MONTEZUMA-RIMROCK FIRE DEPARTMENT

as a ground ALS and BLS ambulance service in the State of Arizona for the transportation of individuals who are sick, injured, wounded or otherwise incapacitated or helpless within the following service area, with the following central operations station and response times:

1. Service Area:

The Montezuma-Rimrock Fire District and northerly portions of I-17 and the Stoneman Lake area. Includes I-17 from MP 291 north to MP 306. Includes Cornville Road from I-17 west about 4.6 miles to the Beaver Head Flat Road. Includes Highway 179 from I-17 west 1.4 miles to MP 300.4. Includes Forest Road 618 east of I-17 and south for 7 miles to just past the M-Diamond Ranch. Includes the Montezuma Castle and Montezuma Well National Monuments, Beaver Creek Estates, McGuireville, Rimrock, Lake Montezuma, the Beaver Creek Ranger Station area, Southwestern Academy area, and those roadways and ranches in between.

2. Central Operating Station: *Lake Montezuma, Arizona (3240 Beaver Creek Road).*

3. Response Times:

- a. *Twelve (12) minutes on eighty (80) percent of all ambulance calls made.*
- b. *Twenty (20) minutes on ninety (90) percent of all ambulance calls made.*
- c. *Forty-Five (45) minutes on one hundred (100) percent of all ambulance calls made.*

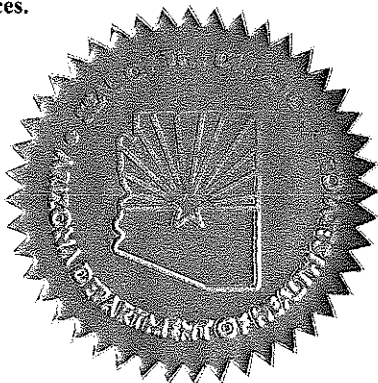
Now, therefore, by virtue of the authority vested in the Arizona department of Health Services, under the constitution and laws of the State of Arizona, does hereby grant this

CERTIFICATE OF NECESSITY

authorizing the operation of the aforesaid ambulance service for a period ending August 31, 2012 unless for cause sooner amended, suspended, revoked or terminated subject to the decisions and orders, and rules of the Department.
