THE ARIZONA DEPARTMENT OF HEALTH SERVICES has found, under the authority of A.R.S. § 36-2232 et seq and Pursuant to Department of Health Services rules, that public necessity requires the operation of

as a ground ALS and BLS ambulance service in the State of Arizona for the transportation of individuals who are sick, injured, wounded or otherwise incapacitated or helpless within the following service area, with the following central operations station and response times:

### 1. Service Area:

*Corporate city limits of the City of Phoenix, and the unincorporated area known as Laveen, bounded by South 27<sup>th</sup> Avenue on the East, stepping down Westward to South 43<sup>rd</sup> Avenue to the point that the 43<sup>rd</sup> Avenue alignment meets the Gila River Indian Community; the Gila River Indian Community on the South; South 83<sup>rd</sup> Avenue on the West; and West Lower Buckeye Road on the North.*

### 2. Legal Address: 520 West Van Buren Street, Phoenix, AZ

### 3. Response Times:

- a. *Code 2 Responses (response without the use of emergency warning devices) - 911 generated dispatches that have pre-hospital personnel on scene where life or limb is not jeopardized that do not require immediate response (less than twenty [20] minutes), and the response is not a prescheduled event. All Code 2 response times will be within thirty (30) minutes.*
- b. *Code 3 Responses (response using authorized emergency warning devices) - 911 generated dispatches when immediate response is required. All Code 3 responses will be:*
  - 1) *Ten (10) minutes on ninety (90) percent of all Code 3 ambulance transports.*
  - 2) *Fifteen (15) minutes on ninety-five (95) percent of all Code 3 ambulance transports.*
  - 3) *Twenty (20) minutes on ninety-nine (99) percent of all Code 3 ambulance transports.*

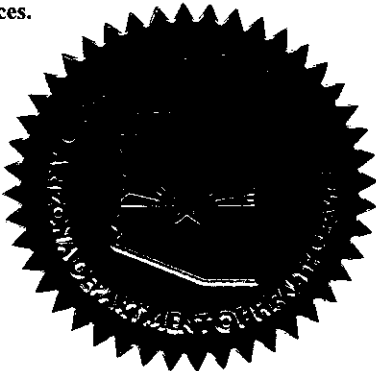
Now, therefore, by virtue of the authority vested in the Arizona department of Health Services, under the constitution and laws of the State of Arizona, does hereby grant this

## CERTIFICATE OF NECESSITY

authorizing the operation of the aforesaid ambulance service for a period ending November 30, 2010 unless for cause sooner amended, suspended, revoked or terminated subject to the decisions and orders, and rules of the Department.
