THE ARIZONA DEPARTMENT OF HEALTH SERVICES has found, under the authority of A.R.S. § 36-2232 et seq and Pursuant to Department of Health Services rules, that public necessity requires the operation of

AJO AMBULANCE, INC.

as a ground ALS and BLS ambulance service in the State of Arizona for the transportation of individuals who are sick, injured, wounded or otherwise incapacitated or helpless within the following service area, with the following central operations station and response times:

1. Service Area:

Starting at the Pima County and Republic of Mexico boundary on State Highway 85; then proceeding north along State Highway 85 to the community of Why and encompassing that community which lies within a one-mile radius of the intersection of state Highways 85 and 86, including along State Highway 86 to the western boundary of the Tohono O'Odham Indian Reservation; then proceeding further north along State Highway 85 to the community of Ajo and encompassing that community and its environs which are bounded by Darby Well Road on the south, the Tohono O'Odham Indian Reservation on the east, Hayworth Road on the north, and the Cabeza Prieta National Wildlife Refuge on the west; then proceeding further north along State Highway 85 to the Pima and Maricopa County boundary and there ending.

2. Central Operating Station: *Ajo, Arizona (410 Malacate).*

3. Response Times:

- a. *Eight (08) minutes on sixty-eight (68) percent of all ambulance calls.*
- b. *Eleven (11) minutes on seventy-seven point five (77.5) percent of all ambulance calls.*
- c. *Fifteen (15) minutes on eighty-seven (87) percent of all ambulance calls.*
- d. *Thirty (30) minutes on ninety-four (94) percent all ambulance calls.*
- e. *Forty-two (42) minutes on one hundred (100) percent of all ambulance calls.*

Now, therefore, by virtue of the authority vested in the Arizona Department of Health Services, under the constitution and laws of the State of Arizona, does hereby grant this

RENEWAL

CERTIFICATE OF NECESSITY

authorizing the operation of the aforesaid ambulance service for a period ending April 30, 2019 unless for cause sooner amended, suspended, revoked or terminated subject to the decisions and orders, and rules of the Department.

PROVIDED, that this certificate shall not be assigned nor transferred unless authorized by the Arizona Department of Health Services.
