THE ARIZONA DEPARTMENT OF HEALTH SERVICES has found, under the authority of A.R.S. § 36-2232 et seq and Pursuant to Department of Health Services rules, that public necessity requires the operation of

TIMBER MESA FIRE AND MEDICAL DISTRICT dba LAKESIDE FIRE DISTRICT

as a ground ALS and BLS ambulance service in the State of Arizona for the transportation of individuals who are sick, injured, wounded or otherwise incapacitated or helpless within the following service area, with the following central operations station and response times:

1. Service Area:

Beginning at a point on the Northerly boundary line of the Apache Indian Reservation Line, as said line existed 1st January 1959, also known as "the Rim Road," where it intersects the north-south center line of section 6, Twp 8N, R23E, G&SRB&M, Arizona, and common to the west boundary of the Pinetop Fire District, thence N along said N-S center line to the NE Corner of the NW ¼ of said Section 6, thence easterly along the North boundary line of said Section 6, at a distance of 240 feet more or less, to the SW corner of Section 31, Twp 9N, R23E, thence northerly along the west boundary line of said Section 31 to the NW corner of said Section 31, common also with the NE corner of Section 36, Twp 9N, R22E; thence westerly along the North boundary line of Section 36 to the NW corner of Section 36, Twp 9N, R22E, thence in a Northerly direction a distance of one half mile more or less to the East-West center line of said Section 25, thence East on EW centerline to the Eastern boundary of said Section 25, thence Northeasterly to the Northeast corner of Section 30, Twp 9N R23E or a GPS point of W109° 56'13.368" N34° 9' 17.12" proceeding in a Northeasterly direction to the NE corner of Section 20 Twp 9N R23E or a GPS point W109° 55'11.4" N34° 10'10.53" proceeding East on the section line to the Southeast corner of Section 13, Twp 9N R23E thence proceeding North along the Eastern boundary line of Section 13, 12 & 1 of Twp 9N, R23E and Section 36, Twp 10N R23E to Northeast corner of Section 36 proceeding westerly along the Northern line of

Now, therefore, by virtue of the authority vested in the Arizona Department of Health Services, under the constitution and laws of the State of Arizona, does hereby grant this

CERTIFICATE OF NECESSITY

authorizing the operation of the aforesaid ambulance service for a period ending November 30, 2018 unless for cause sooner amended, suspended, revoked or terminated subject to the decisions and orders, and rules of the Department.

PROVIDED, that this certificate shall not be assigned nor transferred unless authorized by the Arizona Department of Health Services.

Section 36, of Twp 10N, R23E to the Northwest corner of Section 31 thence proceed south on the western boundary line of section 31 to the SW corner of Section 31, thence westerly along Section 1 and 2, Twp 9N R22E to the North/South center line of Section 2 Twp 9N R22E, Thence proceeding south along the North/South center line of Section 2 to the Northern boundary of Section 11 Twp 9N R22E then continuing in a westerly direction along Northern boundary of Section 11, 10, 9 & 8 of Twp 9N R22E to the Apache Indian Reservation Boundary as said boundary existed January 1, 1959, also known as the Rim Road, thence in a S/SE direction following along the Rim Road to the point of beginning.

Immediate Response Transports and Interfacility Transports

5. Hours of Operation:

24 hours per day – 7 days per week
