

Arizona Marijuana Program August 2021 Monthly Report

In December 2010, Arizona voters passed the Arizona Medical Marijuana Act (AMMA), A.R.S. §36-2801 et seq. The AMMA went into effect on April 14, 2011, making Arizona the fourteenth state to adopt a medical marijuana law. The AMMA designates the Arizona Department of Health Services (ADHS) as the licensing and issuing authority for the Arizona Medical Marijuana Program. The AMMA monthly report highlights the most current program statistics. This includes data on active medical marijuana cardholders as well as transaction data from the sale of medical marijuana at medical marijuana dispensaries. Tables 1-4 reflect data that are point-in time. Table 5-7, 10, 13, and Figure 1 are data from the month of August, 2021. Tables 5, 8-10, 14, and Figure 2 shows cumulative data for 2021. In November 2020, Arizona voters passed the Smart and Safe Arizona Act (SASAA), A.R.S.§36-2802 et seq. As of March 2021, statistics on adult use establishments were included in this report.




As of 9/1/2021, there are a total of 130 medical marijuana dispensaries, with 125 operating facilities.
