THE ARIZONA DEPARTMENT OF HEALTH SERVICES has found, under the authority of A.R.S. § 36-2232 et seq and Pursuant to Department of Health Services rules, that public necessity requires the operation of

VERDE VALLEY FIRE DISTRICT

as a ground ALS and BLS ambulance service in the State of Arizona for the transportation of individuals who are sick, injured, wounded or otherwise incapacitated or helpless within the following service area, with the following central operations station and response times:

1. Service Area:

Part 1: Includes the Legal Geographic boundary of the Verde Valley Fire District as of November 7, 2005.

Part 2: All of Sections 15, 21, 22 and 23 in T15N R3E that are not already included in Part 1.

All of Sections 19, 20, 21, 29 and 30 in T15N R4E that are not already included in Part 1.

Part 3: Also includes the following areas that are currently proposed to be annexed to the Verde Valley Fire District.

All of Sections 17 and 20 in T15N R3E that are not already included in Part 1.

All of Sections 7, 8, 9 and 10 in T16N R4E that are not already included in Part 1.

All of Sections 4, 5, 8 and 9 in T15N R5E not already included in the Sedona Fire District CON or Montezuma-Rimrock Fire District CON.

2. Central Operating Station: *Cottonwood, Arizona (2700 Godard Road).*

3. Response Times:

a. Eight (8) minutes on fifty-five (55) percent of all ambulance calls within CON #123.

b. Ten (10) minutes on seventy-five (75) percent of all ambulance calls within CON #123.

c. Fifteen (15) minutes on ninety (90) percent of all ambulance calls within CON #123.

d. Thirty (30) minutes on one hundred (100) percent of all ambulance calls within CON #123.

Now, therefore, by virtue of the authority vested in the Arizona Department of Health Services, under the constitution and laws of the State of Arizona, does hereby grant this

RENEWAL

CERTIFICATE OF NECESSITY

authorizing the operation of the aforesaid ambulance service for a period ending March 27, 2027 unless for cause sooner amended, suspended, revoked or terminated subject to the decisions and orders, and rules of the Department.

PROVIDED, that this certificate shall not be assigned nor transferred unless authorized by the Arizona Department of Health Services.
